REFER A FRIEND TERMS & CONDITIONS

PROVIDES THE FOLLOWING:

1. WHEREAS the Affiliate is interested in introducing new clients to the company subject to the terms and conditions of the present agreement.
2. WHEREAS AdroFx is interested in acquiring these new clients and can provide its services to them to the best of its abilities.

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. APPOINTMENT

The company appoints Affiliate to introduce clients to the company and Affiliate accepts such an appointment on the terms of this Agreement.

1. INTRODUCTION

1.1 These terms and conditions (“Terms”) form the basis of participating in the AdroFx Refer a Friend Programme.

1.2 By participating in the Refer a Friend Programme, you agree to be bound by these Terms.

1.3 AdroFx reserves the right to vary or cancel any of these Terms at any time.

1.4 The Refer a Friend Programme is open during the period in which AdroFx, in its sole discretion, continues to advise on its Website.

1.5 Capitalised terms used but not defined herein have the meaning given to them in the AdroFx Risk Disclosure Statement, the General Terms, and Conditions (the “AdroFx Documents”), and any references to the AdroFx Documents below shall be construed accordingly.



2. CONDITIONS OF ELIGIBILITY

2.1 The Refer a Friend Programme is available to customers who have satisfied the Eligibility Criteria for (“Eligible Customer”).

2.2 The Refer a Friend Programme entitles an Eligible Client to refer an individual to AdroFx as a New Client.

2.3 The Eligibility Criteria for the Refer a Friend Programme are:

- a) You must be a direct retail client of AdroFx with a real account. If you have any introduction or introduction-type arrangement or are an advertising affiliate/referrer/marketing partner (“Affiliate”) with AdroFx or any referrals thereunder will not qualify for the Refer a Friend Programme.
- b) You must have an existing personal (not commercial) relationship with the person you would like to refer to (“Your Friend”). Your Friend must be 18 years or older.
- c) The Refer a Friend Programme is only available once for each New Client and does not include multiple accounts being opened by the same client. In the case of an eligible joint account that satisfies the Minimum Account Criteria, you will receive one reward.
- d) The Eligible Client must not have a power of attorney or other authority to trade on the New Client’s Account.

2.4 For the Affiliate to withdraw recovery credit the Affiliate should trade 1 Standard Lot for each 10\$ provided to him by the company from the moment when recovery credit was added to his account. The Affiliate can withdraw all recovery credit when the sum of the required lots will be traded.

3. REFERRAL LINK

3.1 The Eligible Client will receive an individual referral link that has a unique tag ID in MyAdro when the Refer a Friend Programme application is completed successfully on MyAdro.



4. REWARD CONDITIONS

4.1 Your Friend must be a New Client of AdroFx (not having previously held an account with AdroFx). All accounts are opened subject to the account type provided.

4.2 To qualify for the Refer a Friend Programme, Your Friend is required to open a real AdroFx Trading Account using your referral link.

4.3 Your Friend must open a real trading account, make the minimum first-time deposit (“FTD”), or higher, and open at least 5-10 trades.

4.4 Once Your Friend meets all the above conditions, the reward will be added to your account.

4.5 If any restrictions apply to your account or the account of Your Friend, the referral will not qualify as an Active Referral until restrictions have been lifted.

4.6 IF the client you will refer will participate in other bonuses that AdroFx offers the clients' Maximum bonus can not be more than 100% of the clients' total deposits (including 100% yearly)

4.7 The client that will be referred will receive a bonus that will help the client in trading therefore this bonus is NOT withdrawable.



5. TERMINATION AND CHANGES

5.1 AdroFx reserves the right to withhold and/or cancel any reward payment where, in AdroFx's view, transactions are made to manipulate the Refer a Friend Programme or where either the Eligible Client or New Client may have breached AdroFx's terms and conditions.
